WITH A VISION OF A CASA VOLUNTEER FOR EVERY CHILD WHO NEEDS ONE, THE AGENCY ASSIGNED 368 VOLUNTEERS TO 510 CASES. ACCORDING TO THE 2015 TEXAS ANNUAL REPORT AND DATA BOOK FROM THE DEPARTMENT OF FAMILY AND PROTECTIVE SERVICES, TARRANT COUNTY HAD THE 2ND HIGHEST NUMBER OF CONFIRMED CASES OF CHILD ABUSE IN THE STATE. TARRANT COUNTY HAD 6,213 CONFIRMED CHILD ABUSE VICTIMS IN 2015. THE VOLUNTEERS SERVED A TOTAL OF 880 ABUSED AND NEGLECTED CHILDREN IN TARRANT COUNTY FOSTER CARE. OF THE 880 CHILDREN SERVED, OVER HALF (52%) WERE UNDER THE AGE OF FIVE, AND THEY REPRESENTED EVERY RACE, ETHNICITY, AND SOCIO-ECONOMIC STATUS. THE 368 CASA VOLUNTEERS SPENT AN AVERAGE OF 17.6 MONTHS ON A CASE, DEMONSTRATING THEIR COMMITMENT TO CHILDREN IN CRISIS.
